The Scholarship Committee wishes to emphasize that applicants **MUST** accurately and completely provide all of the information requested on the application form. Failure to do so will be considered grounds for disqualification.

CSEA Fresno Chapter 125 is pleased to announce that it will award \$500 to four qualified high school seniors who plan to further their education by attending a university, college, or a trade school in the Fall of 2024. Awards are paid out in the following manner: \$500 to be paid in the month of October. Before payment of a scholarship can be made, the recipient **MUST** furnish proof of his/her enrollment as a full-time student. A verification of enrollment from your school must be provided for this purpose. If the recipient of an award fails to provide proof of enrollment, all monies will be forfeited.

You must meet the qualifications listed below and submit the attached application with the required forms. The application must be completed and returned (or post marked) to the Scholarship Committee by April 30, 2024. Page one is to be filled out by applicant (student). Page two is to be filled out by parent or guardian of student. Included are forms that must accompany your two letters of recommendation, to be filled out by someone who is a non-family member (example: teacher, counselor, employer, school staff, etc.). The completed letters of recommendation along with pages three and four **MUST** be returned to the student. Students **MUST** return application and letters of recommendation to the Scholarship Committee Chairperson (address below).

Forms that must be included with application:

- Sealed High School transcript from Counselor or Registrar.
- A Personal Statement by applicant of a minimum of 200 and maximum of 300 words explaining financial needs, plans for future career, work or volunteer experience. (Please sign and date your statement).
- Two Letters of Recommendation along with pages three and four (Non-Family Members).
- ****Please do not seal Letters of Recommendation and verify that page three and page four are included and filled out completely and signed****

Qualifications for 2024 Scholarship application:

- Parent or legal guardian **must be a member in good standing of CSEA Fresno Chapter 125**. If you are a legal guardian, student must be a dependent of the legal guardian who is stated on IRS tax return. Please include a copy of your 2023 IRS tax forms.
- Cumulative Academic Grade Point Average (GPA) of 2.0 or above.
